

# PERMANENT MAKE UP AFTERCARE INSTRUCTIONS

## **IMMEDIATELY FOLLOWING THE PROCEDURE**

- APPLY ICE IF NEEDED. DO NOT EXPOSE THE AREA TO SUN.
- NO CLEANSING CREAMS OR CHEMICALS. GENTLY CLEANSE THE AREA WITH ANTIBACTERIAL SOAP. RINSE WITH WATER, PAT DRY, DO NOT PICK. ALLOW FLAKES OR CRUST TO FLAKE ON IT'S OWN.
- DO NOT SWIM IN FRESH WATER, SALT WATER OR CHLORINATED POOL WATER FOR 10 DAYS. DO NOT LET THE SHOWER HIT DIRECTLY ON AREA.

## **EYELINER:**

- APPLY BABY OIL OR LIQUID TEARS TO EYELINER WITH Q-TIP OR DROP TEARS IN EYES 4 TIMES A DAY.

## **EYEBROWS AND LIPS:**

- APPLY VASOLINE OR AQUAPHOR OINTMENT TO BROWS OR LIPS FOR 10 DAYS 4 TIMES A DAY.

**FAILURE TO FOLLOW AFTERCARE MAY CAUSE LOSS OF PIGMENT OR INFECTION.**

**REMEMBER: COLORS APPEAR BRIGHTER AND MORE SHARPLY DEFINED IMMEDIATELY FOLLOWING THE PROCEDURE. AS IT HEALS THE COLOR WILL SOFTEN.**

A FOLLOW UP APPOINTMENT (TOUCH UP) WILL BE SCHEDULED APPROXIMATELY 2 WEEKS AFTER THE INITIAL PROCEDURE FOR EYELINER AND EYEBROWS. LIPLINER OR FULL LIPS WILL BE SCHEDULED AT 4 WEEKS AS THE LIPS HEAL DIFFERENTLY THAN THE LINER OR BROWS.

1ST TOUCH UP WILL BE INCLUDED IN PRICE. ANY TOUCH-UPS AFTER 3 MONTHS WILL BE CHARGED. IF YOU WANT TO ADD COLORS OR WIDER LINES THERE WILL BE AN ADDITIONAL CHARGE ON YOUR TOUCH UPS.

**AFTER 1 YEAR FUTURE TOUCH UPS WILL BE AT \$50.00. AFTER 3 YEARS \$100.00.**
